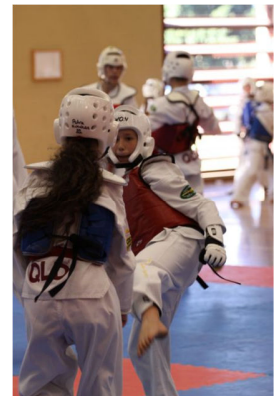

COMPETITION DATES/TIMES	November 26, 2011 Competition will commence at 3pm
VENUE	The Indoor Hall at the South Pine Sports Complex, Cribb Rd, BRENDAL www.spsa.com.au
ENTRIES	Event entries will only be accepted if endorsed by the relevant State Association. Entries CLOSE 15 November 2011
COACHES	All coaches must have current Taekwondo Australia Coaching Accreditation and have their card with them at the event (or have obtained a day pass through the Coach meeting).
WEIGH IN FOR SPARRING	Sparring competitors are required to weigh in at the commencement of the event. Weigh in will be conducted in shorts and t-shirt (not underwear) with an allowance of 0.5kg (500gm). Any player not meeting weight division requirements will be permitted one additional opportunity to meet correct weight within one hour of their original weigh in time.
RULES	WTF Rules with Sparring by Round Robin process where there are 3 entries in the division. If there are only 2 entries in a division only 1 match will be conducted.
AWARDS AND SELECTION	Gold, Silver and Bronze medals will be presented as appropriate. Where points are even, match score differentials will be used to determine the leading competitor per place. In addition, each match will result in points allocated to the participant State and these points will accumulate to determine the awarding of the ORIGIN CHALLENGE CUP perpetual trophy.
SPARRING EQUIPMENT	Sparring competitors must wear WTF approved groin, shin, arm, hand and head protectors. This event will utilize the Daedo electronic hogu system and participants must have their own sensory foot protectors (which will be available for purchase at the event). Head protectors must be white or match the chest guard colour. Mouthguards MUST be worn and must be white or clear.

UNIFORMS/DRESS CODE	A Taekwondo Australia badge must be attached to the top of the left sleeve of the uniform. Only State apparel (or non-club-branded apparel) may be worn by competitors and coaches (no club apparel may be worn, though club badges/embroidery may appear on the participant dobok). Minimum dress code for coaches is closed-in shoes (not thongs or scuffs), tidy shorts or long pants and polo shirt (no singlets).
ENVIRONMENTAL ISSUES	Participants should note that November in Qld is usually hot and need to ensure they appropriately address issues of hydration and weather appropriate apparel.
LIABILITY	All participants take part in this event at their own risk. Though all care is taken, the organizers and their representatives take no responsibility, under any circumstances, for any loss, damage or injury to individuals or equipment.
PRIVACY	Personal details collected are solely for the purpose of the competition involved and are not retained beyond the event. Health information may be shared with first aid personnel if appropriate.
UNCONTESTED PLAYERS	Players uncontested in their own division will be provided with appropriate matchplay where possible and their match result will count accordingly.
ENTRY FEES	Entry fee \$30 per team member of up to 52 athletes (1 athlete per division per state). Spectator admission \$5 per person which will include 1 ticket in the multi-draw raffle.
MATCH TIMES	Sparring match times will be 3 rounds of 2 minutes for the open division and 3 rounds of 1.5 minutes for 14-17 or masters (unless the 12 gap rule ends the match early).
